GENERAL NOTES AND SPECIFICATIONS FOR TOILET EXTENTION	
FOUNDATIONS AND FLOOR SLAB	The contractor / service provider must extend an estimated 4m ² and a 6m ² for the disabled toilet as per the attached plan, contractor to dig trenches 600mm wide and 600mm deep that will receive 600 mm x 250 mm concrete strip footing between 15 - 20 MPa in a strength. A 400mm high,140mm wide cavity wall with klinker bricks / equivalent foundation wall to be constructed with brick force in every layer of brick work, the contractor to omit the interior brick once the wall is 400mm high, this is to allow the concrete to spill into the cavity. The contractor to put down a well compacted layer of sand ,50mm thick that will receive a 250micron damp proof membrane. A concrete slab 85- 100mm thick of 15-20MPA in strength to be cast on top of the DPM (wet proof (membrane) and the concrete surface to be kept wet to prevent cracks from forming.
DPC TESTING	Contractor will be responsible for one (1) DPC tests to be done on the prepared ground works before concrete foundations and floor slabs are cast.

- No concrete is to be cast before all required DCP test have been carried out and compaction of fill and steel reinforcing has been inspected and approved by structural engineer on municipal official.
