RECYCLING RESTARTED / HERWINNING BEGIN WEER

A new service provider, LGE Waste, has started with the collection of green and blue bags on Monday 1 March 2021. George Municipality made the appointment following a tender process, initiated after the previous service provider Interwaste had closed its regional offices in George and ended its contract with the municipality in July last year.

The new service provider takes up the service as per the previous schedule and will be collecting green and blue bags from all areas that have a recent history of recycling. These include most suburbs of George – incorporating more recent participating areas Ballotsview, Borchards, Conville, New Dawn Park, Delville Park, Pacaltsdorp, Parkdene, Protea Park, Rosemore and Sea View – as well as the outer areas of Wilderness, Kleinkrantz, Hoekwil, Victoria Bay and Herolds Bay.

Replacement bags will be issued to every household in the above-mentioned areas in exchange for bags placed out. Implementation in Harlem and Uniondale is currently being investigated to ensure the most effective service, details of which will be announced to the affected communities as soon as arrangements have been finalised.

Service to Lawaikamp and Thembalethu will, for now, be handled on request via the ward councillor or office numbers as listed below. The municipality and service provider hope to commence awareness campaigns in these areas as soon as Covid-19 restrictions allow, with the intent to roll out a more extensive service as more households participate.

Residents can put out four green bags and unlimited number of blue bags together with up to seven black bags on their

scheduled removal day. Blue and green bags will be collected on the same day as black bags, but by different vehicles. Households or businesses that are actively recycling and require additional green or blue bags, can collect from George Municipality Environmental Services or LGE Waste (details below).

LGE Waste, het as nuwe diensverskaffer met die insameling van groen en blou sakke op Maandag , 1 Maart 2021 begin. Die George-munisipaliteit het die aanstelling gemaak na aanleiding van 'n tenderproses, wat begin is nadat die vorige diensverskaffer Interwaste, sy streekskantore in George gesluit en beëindig het.

Die diens word volgens die vorige skedule gehandhaaf en groen en blou sakke word uit alle gebiede opgetel waar herwinning onlangs plaasgevind het. Dit sluit die meeste voorstede van George in, insluitend Ballotsview, Borchards, Conville, New Dawn Park, Delville Park, Pacaltsdorp, Parkdene, Protea Park, Rosemore en Sea View - sowel Wildernis, Kleinkrantz, Hoekwil, Victoria Bay and Herolds Bay.

Vervangingsakke word aan elke huishouding in bogenoemde gebiede uitgereik in ruil vir sakke wat buite geplaas word. Die implementering in Harlem en Uniondale word tans ondersoek om die mees doeltreffende diens te verseker, waarvan besonderhede aan die betrokke gemeenskappe bekendgemaak sal word sodra die reëlings afgehandel is. Die diens aan Lawaikamp en Thembalethu sal voorlopig op versoek, na u betrokke wyksraadslid of kantonnemers soos hieronder gelys, deurgegee word vir hanteering.

Die munisipaliteit en diensverskaffer hoop om met bewusmakingsveldtogene in hierdie gebiede te begin sodra die beperkings van Covid-19 dit toelaat sodat 'n uitgebreide diens in gestel kan word namate meer huishoudings daaraan deelneem. Inwoners kan vier groen sakke en 'n onbeperkte aantal blou sakke tesame met tot sewe swart sakke op hul geskeduleerde verwyderingsdag uitsit. Blou en groen sakke word op dieselfde dag as swart sakke afgehaal, maar deur verskillende voertuie. Huishoudings of ondernemings wat aktief herwin en bykomende groen of blou sakke benodig, kan dit by die George-munisipaliteit se Omgewingsdienste of LGE afhaal. (Besonderhede hieronder)

Role of Municipal Law Enforcement Officers / Rol van Municipale Wetstoepassingsbeamptes

Municipal Law Enforcement Officers may exercise the powers entrusted to peace officers under section 334 of the Criminal Procedure Act (Act 51 of 1977), excluding criminal or illegal action on private property.

They are mainly tasked with the enforcement of George Municipality Bylaws including: Prevention of Public Nuisance and Public Nuisance Arising from the Keeping of Animals; Street Trading, Beach Bylaw and Impoundment of Animals.

These bylaws are extensively set out on our website in the Document section and can be found on www.george.gov.za

Examples of Bylaw related complaints would be, the protection of all municipal property, vandalism of these properties, complaints regarding dogs/animals in town, residential areas, on beaches and where they are allowed and not allowed, as well as illegal dumping activity.

Law Enforcement also monitors noise nuisance, and handles trading permits at demarcated trading spaces.

The Anti-Land Invasion Unit functions in preventing unlawful occupation of municipal grounds and/or assets.

The South African Police Services are responsible for all crime related activities.

Munisipale Wetstoepassingsbeamptes beskik oor die bevoegdheid wat aan vredesbeamptes opgedra is kragtens artikel 334 van die Strafproseswet (Wet 51 van 1977), met die uitsluiting van kriminele of onwettige optrede op privaat eiendom.

Hulle taak is hoofsaaklik om die verordeninge van George Munisipaliteit toe te pas, insluitend: voorkoming van openbare oorlaste, en openbare oorlaste weens die aanhou van diere; Straathandel, strandverordening en skut van diere. Hierdie verordenings word breedvoerig op ons webwerf uiteengesit onder die Dokument afdeling en kan op www.george.gov.za gevind word.

Voorbeeld van sulke klagtes wat verband hou met verordeninge, die beskerming van alle munisipale eiendom, vandalisme van hierdie eiendomme, klagtes rakende honde/diere in die stad, woongebiede, op strande en waar dit toegelaat en nie toegelaat word nie, asook onwettige stortingsaktiwiteite. Wetstoepassing monitor ook geraasoorlas, en hanteer handelspermitte op afgebakende handelsruimtes.


Die Teen-grondbesettingseenheid funksioneer om onwettige besetting van munisipale gronde en/of bates te voorkom.
